Wardens

Joan Peters – People's Warden

Joan Peters retired in 2016, after 24 years as Director of National Corporate Donations at CIBC. Parish Members

David Crawford

David worked in the Australian public sector, which included diplomatic postings as First Secretary to Pakistan (1992-94) and South Africa (1994-98). Prior to that he was a tutor in history at the University of Sydney and in 1999 he moved to the private sector. As David's father was an Anglican priest in the diocese of Sydney, David worshipped in his parish of All Saints, Parramatta, and later at St Albans, Epping (also in Sydney). In London, England, he attended St Paul's Cathedral. In the past, he has served as a member of synod, council member, server, sacristan, lay reader and lay assistant. David is a lawyer previously practicing in Sydney and London prior to coming to Toronto. At St. James

Cathedral, he is a Sidesperson for the 8:00am service, previously served on the Cathedral Council and the St. James Cathedral and Community Refugee Committee, and is also a pro-bono lawyer providing legal advice on refugee matters through a non-profit group.

David Hedley

David held joint positions as a staff physician and scientist at Princess Margaret Hospital for 30 years, until his retirement in 2020. He has spent a long career exploring the boundaries between basic science and human cancer. For most of that time he was agnostic, believing that reductionist science can ultimately explain our existence. About a dozen years ago he underwent a sudden conversion back to active Christianity during a church service, and after a lot of prompting by the Spirit ended up at St James for the 11:00am Palm Sunday service in 2010. He has been a regular at the 11:00am ever since, as well as a frequent attender at Evensong, which he loves. As well as the scriptures, he reads extensively in the Christian literature, including many of the old classics as well as modern writers and thinkers. He now feels able to reconcile Christian faith with science, recognizing that science provides only approximations to truth, not absolute Truth, but when used well, is of enormous benefit to humanity.

Carol Kysela

I am Carol Kysela. The Cathedral Church of St. James has been my parish home for the past 11 years. I came from St. Thomas's Huron Street, another wonderful parish where I had been since 1980. Immediately upon coming to St. James', I was struck by the feeling of a "big tent" from an architectural perspective and an inclusive attitude within the congregation. The respect for liturgy and excellent homilies were important to me as well as the sense of social responsibility. The slightly faded décor in contrast to the soaring ceilings, stained-glass windows, and wonderful music gave me a sense of both home and mystery. That remains so today.

My husband, Ed McDonough, and I have one son who has left the nest but is still located in Toronto! Before retiring my professional career was based around project management for systems development at a large insurance company. I also participated in the St. James adult education committee for some exciting years as well as the 11:00am Sunday school rotation (always exciting in its own way!) Now I am one of the lay leaders for the current Lenten program, "Becoming the Story We Tell".

Fundraising projects have been part of our life at St. James. Ed and I with the EFM group started the annual Palm Sunday Hot Cross Bun fund raiser to support the footcare clinic and Drop-In that we hope it will be back this year. It required about fifty volunteers, so we got to know people from different congregations at St. James. I co-chaired the Affordable Art Affair event to raise funds for the St. James' Community Refugee Committee during the crisis of 2018.
